# 1. Call to Order and Setting of Agenda

# 4. MN Watershed Districts & SWWD History

Axtell provided a presentation covering watershed basics and the history of watershed-based policy management in Minnesota, including the formation of watershed districts state-wide (M.S. 103D, 1955) and the expansion of watershed district responsibilities within the seven-county Twin Cities metro area (M.S. 103B, 1982). He discussed SWWD's historic timeline, including the addition of East Mississippi and Lower St. Croix WMO areas, answering clarifying questions from the CAC members. Axtell discussed BWSR's One Watershed, One Plan program and SWWD's role in the Lower St. Croix Watershed Partnership (LSCWP).

# 5. SWWD Projects Update

Axtell's presentation continued to cover recent and current major SWWD projects including the Central Draw Storage Facility and Overflow, Glacial Valley Park, Campus Greening, Seasons Park, East Mississippi Underground BMPs, Hasenbank Park, and Wilmes Lake Alum Treatment Facility.

# 6. Artist-in-Residence (Photography) Pilot Program

Axtell provided a synopsis of SWWD's new Artist-in-Residence Pilot Program and requested up to two CAC volunteers to serve on the application review committee. Detailed information about scheduling for the review sessions will be provided by staff at a later date. Patty Goertz and Howard Markus volunteered to serve on the review committee. Bill Sumner volunteered to serve as a backup committee member.
